Batteries in Transport - Applicable U.S. Hazardous Materials The battery must be protected against short circuits and securely packaged; The battery and outer packaging must be plainly and durably marked "NON- SPILLABLE" or "NON-SPILLABLE" eCFR :: 49 CFR 173.159 -Batteries must be securely cushioned and packed to prevent shifting which could loosen terminal caps or reorient the terminals. Batteries contained in devices must be securely installed.
