2. What telecommunications related activities and services in the Kyrgyz Republic are subject to licensing requirements? What is Kyrgyz energy policy? Outlook to the Kyrgyz energy policy

To unleash the RE capacity, the Kyrgyz government introduced the law titled "Renewable energy sources (RES)" in December (Ministry of justice of the Kyrgyz Republic, ). Kyrgyzstan was the first country in Central Asia who implement RE-based law. When does the new energy regulation come into force in Kyrgyz Republic? In November , the new regulation came into force named "On the conditions and procedure for the implementation of activities for the generation and supply of electricity using renewable energy sources" (Cabinet of Ministers of the Kyrgyz Republic, ).

Are telecommunications services licensed under Kyrgyz law? Under Kyrgyz law a series of activities related to telecommunications services are subject to licensing, including: - devices, networks, lines, structures, systems. While each activity related to telecommunications is generally licensed separately, a single license for several activities may be issued when it is technically feasible.

What are the objects of regulation in Kyrgyz Republic? According to the law, objects of regulation are: "production, consumption, and sale of heat, electric energy and fuel using renewable energy sources, as well as the production and supply of equipment and technologies in the field of renewable energy source" (Ministry of justice of the Kyrgyz Republic, ).

Does Kyrgyzstan have a good power supply? According to the results of the quality of energy delivering services survey in Kyrgyzstan made by the National Statistical Committee in , "only 11.8 % of households had uninterrupted power supply, while 64.4 % had power cut several times a year and 0.5 % had daily power cuts" (National Statistical Committee of the Kyrgyz Republic, ).

Kyrgyzstan - a Central Asian country - faces a high degree of energy insecurity. Especially the Kyrgyz power sector suffers from outdated infrastructure and is not capable of fulfilling the growing and fluctuating int Kyrgyzstan's transition to renewable ener
