What is a 5 GW tariff quota? By the end of July, there was a 5 GW tariff rate quota (TRQ) for cells. On August 12, the U.S. raised the annual TRQ for cells from 5 GW to 12.5 GW, which is applied to cells imported after August 1, , while imports exceeding the old 5 GW limit before August 1 are subject to the Section 201 tariffs. Should rooftop solar quotas be distributed at subsystem/cluster level? As of , the Section 201 tariff rate for cells and modules is 14.25%, with a yearly decrease of 0.25%, set to expire on February 6, . In May , the U.S. removed the tariff exemption for bifacial modules. By the end of July, there was a 5 GW tariff rate quota (TRQ) for cells. How many GW of solar cells has the US imported? The U.S. has imported nearly 4.5 GW of cells from February to August, reaching 89% of the initial 5 GW quota limit. Overall, the increasing TRQ aligns with the rising market demand. Notably, this policy adjustment suggests that US authorities recognize the necessity of current cell imports in supporting the domestic PV industry. When will Solaris rebate quotas be distributed? b.
