Electricity costs in the Solomon Islands are the highest in the Pacific and among the highest in the world, with an average retail electricity tariff of US\$0.8 per kilowatt-hour (kWh), 48 more than twice the regional average of US\$0.29 per kWh, according to the World Bank. "The high reliance on imported fossil fuels for diesel generators, low renewable energy penetration, excess capacity of diesel plants, low production efficiency, and the lack of an independent regulator all contribute to high electricity tariffs," the World Bank says in its latest Economic Report on Solomon Islands released this week. It says the Solomon Islands Government maintains a database of over 100 potential hydropower sites with over 300 MW of generation potential, yet only a handful are close to load centers.
